2. Differentiate between FDA-approved synthetic Cannabinoid products.
3. Discuss the recent changes and possible future ramifications surrounding medical marijuana.
4. Appraise the pros and cons of medical marijuana and cannabinoid.

1. Cite several suggested regulations to the areas in which marijuana can be sold.
2. Name suggested rules as to the purchase of marijuana products.
3. Denote what concentrations of marijuana might be appropriate for sale.
4. Determine when to and when not to make a Cannabis product sale.
